IHEC Regulations 6 - UN Unofficial Translation

**Based on the authority given to the BoC in (Article 4 Item 8) of IHEC Law No 11 of 2007, and according to the Amended Iraqi Kurdistan Parliamentary Elections Law No. 1 of 1992 the following regulation was issued:**

**Political Entities Agents Of  
Kurdistan Region parliamentary Elections-Iraq  
Regulation No. 6 - 2009**

**Preamble**

IHEC has been established based on Law NO. 11 of 2007 to be the unique, independent, neutral, body In Iraq having moral personality and subject to the oversight of CoR

**Part 1  
(Definitions)**

The following definitions reflect the meaning explained in front of each:

1. IHEC: Independent High Electoral Commission
2. PE's Agent: a representative of PE assigned to observe electoral process and being accredited according o procedures put by the IHEC.
3. Code of conduct: A set of principles and commitments published by the IHEC to assure the performance of electoral observers are in accordance with IHEC Laws and regulations

**Part 2  
(Accreditation of PEs' Agents)**

1. Registered PEs' have the right to nominate their agents to observe the electoral process and the IHEC will accredit them according to their procedures.

2. In order to accredit PEs' Agents, they should sign on and certify their adherence to the code of conduct. The IHEC will have the right to withdraw the accreditation of any agent who breaches the code.

### **Part 3**

#### **(Agents' performance conditions)**

1. IHEC is not responsible to provide any means of communication, transportation, safety , or provide any other logistic support for the PEs' agents
2. Each PE is responsible to provide the entire support, and the required expenditures to accomplish the work of its agents, in addition , agents are not allowed to utilize any of IHEC equipments or vehicles
3. PEs are committed to notify their accredited agents with the regulations, procedures, and code of conduct issued by IHEC before starting with any activity
4. Political entities agent should sign accreditation badges upon receipt, and he should also hold additional IDs -contain agent's photo for verification by electoral centers' staff.
5. Under any circumstances, the agent may not interfere in the electoral process, but they may draw the attention of IHEC staff in the registration centers, CEO, or BoC regarding any cases occurred during their presence, and the IHEC employees are not abided to react to it.
6. The PEs agents have the right to submit a complaint about any electoral violation in any stage of the electoral process.

### **Part 4**

#### **(Enforcement date)**

1. This regulation shall enter into force from date of ratification by BoC on 4/15/2009
